

Official Online Contest Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED.

1. HOW TO ENTER THE CONTEST

a. Follow the links and instructions to enter and submit your first name and last name, complete address, city, state, zip code, telephone number, date of birth, and a valid email address in the online entry form. Only one internet entry per person and one internet entry per email address is permitted. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible by assigning email address or the domain associated with the submitted email address. Multiple participants are not permitted to share the same email address. All entries submitted become the sole property of Victoria Skimboards and will not be acknowledged or returned. Use of any device to automate entry is prohibited. Proof of submission of an entry shall not be deemed proof of receipt by Victoria Skimboards. Victoria Skimboards' computer is the official time keeping device for the sweepstakes. Victoria Skimboards is not responsible for entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties or other technological glitches.

b. ONE ENTRY PER PERSON

2. ELIGIBILITY RESTRICTIONS

a. The contest is open to all persons of all ages. Employees of Victoria Skimboards, its licensee, and each subsidiary, and affiliates, their advertising agencies, participating sponsors/promotional partners, and the members of their immediate families and or households are ineligible to participate or win.

b. Only one winner per household is permitted in any Contest administered by Victoria Skimboards and winners may only win once every 30 day period.

c. Entrants are required to provide truthful information and Victoria Skimboards will reject and delete any entry that it discovers to be false or fraudulent. Victoria Skimboards will disqualify any entry from individuals who do not meet the eligibility requirements, and Victoria Skimboards will also delete any entry received from persons under the age of 13 in compliance with the Children's Online Privacy Protection Act that do not have written consent from their parents.

d. No prize substitutions, cash equivalent, or transfer of prizes permitted except at the sole discretion of Victoria Skimboards. Prize subject to availability and Victoria Skimboards reserve the right, at their sole discretion, to award a prize of greater or equal value if the advertised prize is unavailable. All other costs not specifically stated herein, including, but not limited to, shipping are the responsibility of the winner. Shipping are solely the responsibility of the winner.

prior written consent of the winner and therefore, winner assumes the risk of its loss. Victoria Skimboards is not responsible for the safe arrival of a prize or prize certificate.

3. SELECTION OF WINNERS

a. Decisions of Victoria Skimboards management with respect to the Contest are final.

b. ODDS OF WINNING DEPEND UPON THE NUMBER OF ENTRIES RECEIVED

c. Winners must execute and return any required affidavit of eligibility and/or liability/publicity release within 30 (30) days of notification attempt or prize will be forfeited and an alternate winner may be chosen randomly from entries received. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility and liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, potential winner forfeits prize.

4. CONDITIONS

a. By participating in the sweepstakes, the winner or winners agree to have their name, voice, or likeness used in any advertising or broadcasting material relating to this sweepstakes without additional financial or other compensation, and, where legal, to sign a publicity release confirming such consent prior to acceptance of the prize.

c. Prior to awarding any prize or prize certificate, Victoria Skimboards in its sole discretion may require sweepstakes winner to sign a liability release, agreeing to hold Victoria Skimboards, its corporate licensee, and each of their parent, subsidiary and affiliated corporations, and the officers, shareholders, directors, employees, agents and representatives of each of them harmless against any and all claims or liability arising directly or indirectly from the prize or participation in the Contest.

Victoria Skimboards, in its sole discretion, reserves the right to disqualify any person tampering with the entry process, the operation of Victoria Skimboards' website or is otherwise in violation of the rules. It further reserves the right to cancel, terminate or modify the sweepstakes if it is not capable of completion as planned, including infection by computer virus, bugs, tampering, unauthorized intervention or technical failures of any sort.

e. Victoria Skimboards reserves the right to make changes in the rules of the Contest, including the substitution of a prize or equivalent value, which will become effective upon announcement.
